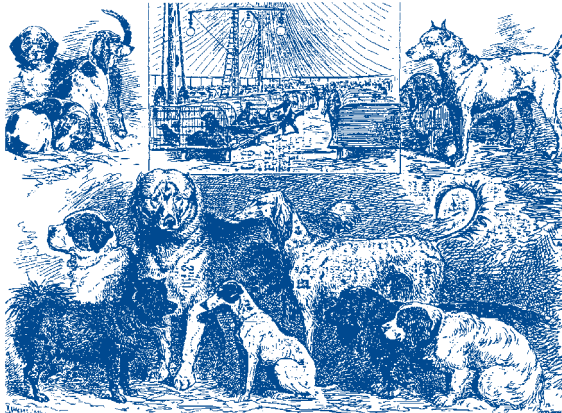

Severe penalties will be imposed on Exhibitors who, in the opinion of the Committee, have left their dog(s) in a distressed condition.

EXHIBITORS PLEASE NOTE

The committee and their immediate family members will not exhibit in breed, AV or Stakes classes at SCCA Southern Counties Canine Association Championship Show is a **FOUR DAY SHOW**
(Not separately classified Exhibitors may only enter on the day of their Group)

THERE WILL BE COMPETITIONS FOR BEST PUPPY IN GROUP/SHOW, BEST VETERAN IN GROUP/SHOW, BEST JUNIOR IN GROUP/SHOW and BEST SPECIAL BEGINNER IN GROUP. *Those eligible to compete for Best Veteran in Group/Show are dogs/bitches entered in Breed, AVNSC and AV Imported Breed Register Veteran classes only and those eligible to compete for Best Junior in Group/Show are dogs/bitches entered in Breed, AVNSC and AV Imported Breed Register Junior classes only. N.B. If your dog wins Best Puppy/Best Junior/Best Veteran in Breed and also wins Best of Breed please ensure that the Group Steward is aware.*

Breed Judging commences at 9.30 am promptly unless notified otherwise on passes and/or in the Dog Press.

If, in the event of a change of judge or other emergency, the order of judging is changed this will also be announced in the Dog Press where time allows. While we do everything possible to help the exhibitor it is the exhibitors' responsibility to be in time for their classes.

ORDER OF STAKES CLASSES: Main Ring A — 9.00 am: KC Breeders' Competition. *The stakes running order will be on the information sheet sent to all exhibitors with their passes and please listen for announcements on the day.*

GROUP JUDGING: Adult Groups will be held in the Main Ring commencing at approx 4.15 pm each day. The Puppy, Junior, Veteran and Special Beginner Groups will run in separate rings, with the final cut being made in the Main Ring. Please listen for the announcements as the 10 minute rule must be strictly adhered to. On the last day, following the Adult Groups in the Main Ring, the order of judging will be Best in Show, Best Puppy in Show, Best Junior in Show and Best Veteran in Show.

You will receive a detailed map with your pass which gives you information on your benching area, judging ring and wet weather judging area.

UN-ENTERED DOGS: There will be no tent for unentered dogs. Dogs MUST be entered at the show to be allowed on the showground either Not for Competition or as a Spectator Dog which will provide them with a pass out through security. The Association will charge a fee of £10.00 for Spectator Dogs for any number of dogs owned by the same person.

EXHIBITORS PASSES - FOR ON-LINE ENTRIES ONLY: You will not receive your Exhibitors Pass through the post because they will be delivered to you through your on-line account. You will be informed by an e-mail when your passes are ready, which will be approximately two weeks before the show. The e-mail will include details on how to print your Exhibitors Pass and any other Show Information. ***Your ring number(s) will be included as part of your pass and you must print this out and take it with you to the show for use in the ring.***

Exhibitors making postal entries will receive their Exhibitors Passes by post in the usual way.

If you have not received your pass seven days before the start of the show please contact the printers (info@fossedata.co.uk / 01788 860960)

Return money will be paid to Group winners, Puppy Group winners, Junior Group winners and Veteran Group winners from the first, second and third days if the exhibit is brought to compete on the fourth day.

RULES and REGULATIONS

Vicious dogs are not eligible and must not be brought to the Show

Exhibitors are held responsible for any damage done by their dog during the exhibition

The Show will be held under Kennel Club Rules and Show Regulations

1. On the days of the Show, dogs will be received from 7.00 am. The show will be open to the public from 9.00 am.
2. Dogs will be received until 12.00 noon after which no dogs may be received except under exceptional and unforeseen circumstances and by special permission of the Show Management. It is the exhibitor's responsibility to ensure that exhibits are available for judging when required.
3. Judging will commence at 9.30 am except for those dogs marked in the schedule or notified through the dog press.
4. Exhibits may be removed at 11.00 am. They may not be removed any earlier unless by written order of the Veterinary Surgeon, Veterinary Practitioner or of the Show Management and then only in very exceptional and unforeseen circumstances which must be reported to the Kennel Club. The Show will close half an hour after all judging has been completed at which time dogs must be removed.
5. The entry fee for EACH DOG for the first class is £30.00 and £6.00 for subsequent classes for that dog. The entry fee for a breed for which CCs are not on offer AT THIS SHOW is £16.00 for the first class and Not For Competition is also £16.00. The fee for the KC Breeders' Competition is £15.00 per team. There will be a flat rate of £10.00 per dog for any exhibitors entering over 5 dogs (the 6th dog onwards will be at the reduced rate, the previous 5 dogs will pay full price). The dogs must ALL be in the same ownership and entered on the same entry form. This includes CC, non-CC and Not for Competition entries. **N.B. There will be an additional fee of £2.00 per dog for on-line entries made after the postal closing date.** Catalogues: £7.00 each (will not be available on the day without voucher) [redeem by 12 noon]. On-line catalogues: £4.00 per day. Car Parking for exhibitors and spectators: £5.00 pre-paid with entries (£10.00 on the day).
No fees will be returned on the grounds of non-receipt of passes etc. Entry fees will not be refunded once an entry is made, the entrance fee of a dog entered but not brought to the show will be forfeited. There will be no spectator admission fee.
6. Prize money is on offer in the Stakes Classes only (see classification for details). **All prize money MUST be claimed by 4.00 pm on the final day of the Show.**
7. The Committee reserves to itself the right to refuse entries on reasonable grounds. The Committee is also empowered to exclude any dog which is not in a fit state for exhibition from disease, vice, natural or other causes and if such exclusion takes place the entrance fee will be forfeited. Rule F (1) (15).
8. Puppies under six calendar months of age on the first day of the Show are not eligible for exhibition, i.e. born on or after **1st December 2023**.
9. The mating of bitches within the precincts of the Show is forbidden.
10. **Best Puppy in Show:** Where a Best Puppy in Show competition is scheduled the Best Puppy in Show is a puppy which has competed and has been declared Best Puppy in Breed, Best Any Variety Not Separately Classified Puppy or Best Any Variety Imported Breed Register Puppy. A puppy is a dog of six and not exceeding twelve calendar months of age on the first day of the Show. Where the Best of Breed, Best in Group or Best in Show is a puppy it may, at the discretion of the judge, be awarded Best Puppy in Breed, Best in Group and Best Puppy in Show respectively. Similarly, if the Reserve Best of Breed, Reserve Best of Group or Reserve Best in Show is a puppy which has only been beaten by an adult dog it may, at the discretion of the judge, be Best Puppy in Breed, Best Puppy in Group and Best Puppy in Show respectively. Consequently, selection of Best Puppy in Breed, Best in Group and Best Puppy in Show must follow the selection of Best of Breed and Best in Show respectively.
 - a. Shows Judged on the Group System - (Definition; Shows judged on Group System - Refer to Regulation F(1)27.b)
 - 1) *Best Puppy in Breed:*
 - A Best Puppy may be declared in each breed from puppies entered and unbeaten by another puppy in the breed classes.
 - A Best Puppy may be declared from the Any Variety Not Separately Classified class(es).
 - A Best Puppy may be declared from the Any Variety Imported Breed Register class(es).
 - 2) *Best Puppy in Group:* Best Puppy in Group and subsequent Puppy Group placings must be selected from:
 - a) Those puppies declared Best Puppy in Breed.
 - b) The puppy declared Best Puppy from the Any Variety Not Separately Classified classes in each Group.
 - c) The puppy declared Best Puppy from the Any Variety Imported Breed Register classes in each Group.
 - 3) *Best Puppy in Show:* Best Puppy in Show must be selected from the Best Puppy in Group winners.
 11. **Best in Show:** The dog declared Best in Show is a dog which has competed and has been declared Best of Breed, Best Any Variety Not Separately Classified or Best Any Variety Imported Breed Register.
 - a. Shows Judged on the Group System
 - 1) *Best of Breed:* Where a breed is separately classified a Best of Breed may be declared but only from those dogs which have received a first prize in a breed class at the show. Where separate classes are provided for each sex of a breed a Best of each Sex must be declared.
NOTE: The Best of Breed/Best Any Variety Not Separately Classified/Best Any Variety Imported Breed Register award relevant to a Category 3 Breed will not be confirmed until the dog has passed an examination by the General and Group Championship Show Veterinary Surgeon.
 - 2) *Best of Group:* Best of Group and subsequent Group placings must be selected from:
 - a) The Best of Breed winners in each Group.
 - b) The dog declared Best from Any Variety Not Separately Classified classes in each Group.
 - c) The dog declared Best from Any Variety Imported Breed Register class or classes in each Group.
NOTE: The dog declared Best of Breed/Best Any Variety Not Separately Classified/Best Any Variety Imported Breed Register from a breed designated by the Kennel Club as a Category 3 Breed is not eligible to compete in the Group competition unless it has passed an examination by the Show's Veterinary Surgeon. If the dog fails to pass the examination it is ineligible to compete in the relevant Group.

- 3) **Best in Show:** Best in Show must be selected from the Best of Group winners. Reserve Best in Show must be selected from the remaining Group winners following the selection of Best in Show.
12. Exhibits will not be admitted to Best in Show competition after a period of ten minutes has elapsed since the announcement that exhibits are required for judging, unless they have been unavoidably delayed by previous judging not being completed on time, and then only with the special permission of the Show Management.
 13. Exhibitors must not pick up dogs by their tails and leads when lifting them **nor handle a dog in a manner which causes its feet not to touch the ground when on the move**. This is not acceptable. Exhibitors should note that such practice would constitute harsh handling and reports of such practice will be referred to the Committee under Kennel Club Show Regulation F11.
 14. All exhibitors must be familiar with Kennel Club Regulation F (Annex B) - Regulations for the Preparation of Dogs for Exhibition.
 15. All dogs resident outside of the UK must be issued with a Kennel Club Authority to Compete number before entry to the show/event can be made. All overseas entries without an Authority to Compete number will be returned to the exhibitor/competitor.
 16. **Dogs in Vehicles on Hot Days.** Your dog is vulnerable and at risk during hot weather and the Kennel Club offers the following guidance to help guide you through the do's and don'ts travelling to and whilst at KC licensed events.
 - When travelling to a show please take a moment to consider whether the route to the show is on a busy holiday route, and leave earlier to avoid increased time in traffic jams.
 - If your vehicle is not air-conditioned seriously consider whether travelling to the show is a good idea at all.
 - The vehicle should be as fully ventilated as possible, and plenty of stops should be taken, with lots of water available to drink.
 - Ensure your dog is not sitting in full sunlight. There should be plenty of free flowing air around the dog.
 - When at the show, never leave your dog in the vehicle.
 - Keep the dog in the shade - take your own shade for example a large umbrella and always have plenty of water available to drink so your dog stays well hydrated.
 - Avoid your dog taking part in unnecessary exertion, or from standing in exposed sunlight for extended lengths of time.

Remember, if you feel hot your dog is very likely to feel much hotter and dehydrated, and this could lead to dire results. Please look after your dog's welfare. **WARNING: IF YOUR DOG IS FOUND TO BE AT RISK FORCIBLE ENTRY TO YOUR VEHICLE MAY BE NECESSARY WITHOUT LIABILITY FOR ANY DAMAGE CAUSED.**
 17. Anyone whose dog is entered at a Kennel Club licensed event should take all reasonable steps to ensure the needs of their dog(s) are met, and should not put a dog's health and welfare at risk by any action, default, omission or otherwise. Breach of the Kennel Club Regulations in this respect may be referred to the Board for disciplinary action under Kennel Club Rules and Regulations. The use of pinch collars, electronic shock collars, or prong collars, is not permitted at any show licensed by the Kennel Club. This shall apply at the venue or within the precincts of the show.
 18. Not for Competition entries will be accepted. Details of each dog so entered must be recorded on the entry form and must be Kennel Club registered. **Not for Competition entries will only be accepted for dogs aged 4 calendar months of age or over on the first day of the Show.**
 19. No modifications will be made to this Schedule except by permission of the Board of the Kennel Club, which will be followed by advertisement in the Canine Press wherever possible.
 20. All rules and regulations, or definitions or instructions of the nature of rules and regulations, printed for convenience in other parts of this schedule shall be deemed to be regulations of the Committee, and shall have the same effect as if they formed part of these Regulations.

An announcement prior to the date of closing of entries in "Our Dogs" of any alteration or addition made in the schedule or in these regulations, shall be deemed to be sufficient notice thereof.

Every exhibitor making an entry or entries at or for this show shall be deemed to have agreed to abide by the Kennel Club Rules and Show Regulations and by these regulations, and it is on this understanding only that entries are received.
 21. All postal entries must be made on or before **Monday, 22nd April 2024 (Postmark)** upon forms enclosed for that purpose. The entry fees must be forwarded to the Secretary with the completed entry form on or before **Monday, 22nd April 2024 (Postmark)** or entry will not be accepted. No acknowledgement will be sent unless a stamped addressed postcard is sent with entries. **On-line entries** can be made up until midnight on **Thursday, 2nd May 2024** at www.fossedata.co.uk.
 22. The Committee is empowered to exclude or remove any dog which, in the opinion of the Show Management and/or the Veterinary Surgeon is not in a fit state for exhibition owing to disease, vice or any other cause. If such exclusion takes place either before or after the dog is judged, the entrance fee will be forfeited.
 23. Exhibitors will be responsible for their dogs being in time for judging.
 24. Should any judge be prevented from fulfilling their engagement, the Executive Committee reserve to themselves the right of appointing other judges to fulfill their duties. Exhibitors are at liberty to withdraw from competition but no entry fees can be refunded. (Vide Kennel Club Show Regulation).
 25. The judges will be instructed and empowered to withhold the prize or prizes in any class if, in their opinion, the dog or dogs exhibited do not possess sufficient merit. Judges are not empowered to give prizes beyond those offered in the Schedule. Any such award shall not have any value or count as a win except if the consent of the Secretary be first obtained in writing. (Vide Kennel Club Show Regulation).
 26. The owner, exhibitor, handler or other person in charge of a dog at Kennel Club licensed events must at all times ensure that the dog is kept under proper control whilst at the licensed venue, including its environs, car and caravan parks and approaches. This Regulation applies before (at any time during the set up period at the venue), during the event and afterwards (at any time during the breakdown of the event).
 27. Any owner, competitor, handler or other person in charge of a dog is required to remove as soon as possible any fouling caused by their dog(s) at any Kennel Club licensed show within the licensed venue and within the environs of that event including car and caravan parks and approaches. Adequate receptacles for the disposal of such fouling will be provided.
 28. All gangways must be kept clear at all times and free from obstructions such as grooming tables, etc. Any obstructions will be removed by authorised officials (Vide Kennel Club Show Regulation). Special places will be provided for the cleaning, preparation and exercising of exhibits and no other place on the showground must be used for such purposes.

29. **Veterinary Examination:** A Veterinary Surgeon will be in attendance throughout the Show.
30. **Safety Officer:** A Safety Officer will be in attendance throughout the show. Exhibitors and spectators are reminded that just as Southern Counties Canine Association has a responsibility to ensure the health and safety of all those attending their event, all those present have a duty and responsibility for their own safety. They are therefore expected to take the greatest care to avoid guy ropes, uneven surfaces and other hazards which are inevitable and integral elements of a dog show. Those bringing and using portable items of equipment such as folding chairs, trolleys, gazebos, cages and grooming tables also have a responsibility to ensure that their tools, equipment and collapsible furniture is used and erected safely and does not constitute a hazard to others. Exhibitors are also reminded that they should wear appropriate clothing and footwear for the prevailing conditions on the site. Exhibitors show at their own risk if conditions are not ideal.
31. **Gazebos - please note the following regulations regarding the erection/use of Gazebos within the confines of the showground:** a) Gazebos must be of the 'pop-up' type which do not have guy ropes and are staked at the corners. b) You and those helping you erect the gazebo/s must all be over 18. c) You carefully follow the manufacturers instructions as to the safe and secure erection of the gazebo. d) You observe the recommended weather/wind restrictions in its use. e) You follow the guidance and instructions of the show society.
32. Committee members of SCCA will patrol grooming areas throughout the show.
33. The Committee will not be responsible for the loss, detention of, or damage to any dog, person or property whether arising from accident, or any other cause whatever, or from any act or omission of itself, its officers, agents, servants or others or the damage done by the exhibitor to any person or property.
34. Parents will be held responsible for any damage to property or equipment caused by their children within the environs of the Show.
35. A dog may be disqualified by the Board of the Kennel Club from any award, whether an objection has been lodged or not, if proved amongst other things to have been: a) registered or recorded as having been bred by the scheduled Judge. This shall not apply to a Judge appointed in an emergency; b) exhibited without payment of appropriate entry fees.
36. Every exhibitor shall ensure that whilst the dog is being exhibited, its handler shall display the correct ring number.
37. **Photography and Video Rights:** The Organisers would like to bring the regulation on photography and filming to the attention of exhibitors, trade stands, press and visitors. It is a condition of all those attending the event that no filming or other form of recording may be taken or made at the venue without express written permission of the organisers. The taking of photographs in the venue for sale or reward is strictly prohibited except with the written permission of the Organisers. Press accredited photographers are provided with permission to take photographs ONLY for use in newspapers, magazines and internet sites - this is for news purposes only. There is no objection to the general public taking photographs or video film of general views of the Show, provided that these are for private use only. Specific dogs may be photographed only with the approval of the exhibitor. No photography or filming is permitted in breed judging rings whilst judging is actually taking place. However, judges may allow it to happen at the end of classes or after the Challenge Certificate is awarded. Filming and flash photography is allowed from outside the rings at all times unless the operation of the camera is actually affecting exhibits. However, if a powerful flash unit is used or it is clear that exhibits are being affected, a ring steward or the judge is empowered to stop the person concerned. Cinematograph or television equipment may only be used at the Show if a permit has been issued by the Organisers.

DEFINITIONS OF CLASSES

The word 'dog' includes both sexes

PUPPIES UNDER SIX CALENDAR MONTHS OF AGE ON THE FIRST DAY OF THE SHOW ARE NOT ELIGIBLE FOR EXHIBITION

In the following definitions, a Challenge Certificate includes any Show award that counts towards the title of Champion under the Rules of any governing body recognised by the Kennel Club. Wins at Championship Shows in breed classes where Challenge Certificates are not on offer shall be counted as wins at Open Shows.

In the case of a dog owned in partnership and entered in Members' classes or competing for Members' Specials each partner must at the time of entry be a member of the Society.

In estimating the number of awards won, all wins up to and including the seventh day before the first closing date shall be counted when entering for any class i.e. Monday, 15th April 2024.

Wins in Variety classes do not count for entry in Breed classes but when entering in Variety classes, wins in both Breed and Variety classes must be counted. First prizes awarded in any classes defined as Special do not count towards eligibility.

If an exhibitor reports before the judging of a class or classes that a dog has been entered which is ineligible, the exhibitor may choose one of the following options:

(1) *Withdrawal*

The dog may be withdrawn from competition subject to the conditions of Regulation F.(1).19.

(2) *Transfer*

- a) If a dog is ineligible for a class or classes as regards its breed, colour, sex, weight or height the Show Secretary shall transfer it to the equivalent class or classes for the correct breed, colour, sex, weight or height and, in the event of there being no equivalent class, Minor Puppy and Puppy excepted, to the Open class for the correct breed, colour, sex, weight or height.
- b) If an exhibit is entered incorrectly in a Minor Puppy class, Puppy class or Junior class, which is over age but under twelve calendar months of age, eighteen calendar months of age or twenty four calendar months of age respectively, the Show Secretary shall transfer the exhibit to the Puppy class, Junior class or Yearling class respectively for the correct breed, colour, sex, weight or height and in the event of there being no Puppy, Junior or Yearling class to the Open class for the correct breed, colour, sex, weight or height.
- c) For any reason other than the above, the Show Secretary shall transfer it to the Open class for the correct breed, colour, sex, weight or height.

- d) If an exhibit arrives late and misses a class, even if it is the only class in which the dog is entered, the dog may not be transferred to any other class.

MINOR PUPPY For dogs of six and not exceeding nine calendar months of age on the first day of the Show (i.e. born between 30th August 2023 and 30th November 2023 inclusive).

PUPPY For dogs of six and not exceeding twelve calendar months of age on the first day of the Show (i.e. born between 30th May 2023 and 30th November 2023 inclusive).

JUNIOR For dogs of six and not exceeding eighteen calendar months of age on the first day of the Show (i.e. born between 30th November 2022 and 30th November 2023 inclusive). This Show has a Best Junior in Group competition: please note, only dogs entered in Breed, AVNSC and AV Imported Breed Register Junior classes are eligible to compete.

YEARLING For dogs of twelve and not exceeding twenty four months of age on the first day of the Show (i.e. born between 30th May 2022 and 30th May 2023 inclusive).

NOVICE For dogs which have not won a Challenge Certificate/CACIB/CAC/Green Star or three or more First Prizes at Open and Championship Shows (Minor Puppy, Special Minor Puppy, Puppy and Special Puppy classes excepted, whether restricted or not).

GRADUATE For dogs which have not won a Challenge Certificate/CACIB/CAC/Green Star or four or more First Prizes at Championship Shows in Graduate, Post Graduate, Minor Limit, Mid Limit, Limit and Open classes, whether restricted or not where Challenge Certificates were offered for the breed.

POST GRADUATE For dogs which have not won a Challenge Certificate/CACIB/CAC/Green Star or five or more First Prizes at Championship Shows in Post Graduate, Minor Limit, Mid Limit, Limit and Open classes, whether restricted or not where Challenge Certificates were offered for the breed.

LIMIT For dogs which have not become show Champions under Kennel Club Regulations or under the rules of any governing body recognised by the Kennel Club, or won 3 or more CC/CACIB/CAC/Green Stars or won 7 or more First Prizes in all at Championship Shows in Limit or Open Classes, confined to the breed, whether restricted or not, at Shows where Challenge Certificates were offered for the breed.

OPEN For all dogs of the breeds for which the class is provided and eligible for entry at the Show.

VETERAN For dogs of not less than seven years of age on the first day of the Show. This Show has a Best Veteran in Show competition: please note, only dogs entered in Breed, AVNSC and AV Imported Breed Register Veteran classes are eligible to compete.

SPECIAL BEGINNERS For owner, handler or exhibit not having won a Challenge Certificate or Reserve Challenge Certificate, or for those breeds not allocated Championship Status, Best of Sex or Reserve Best of Sex at a Championship Show.

BIRDBROOK VETERAN STAKES For dogs of not less than seven years of age on the first day of the Show.

CHAMPION STAKES For dogs which have been confirmed a Champion or Show Champion under Kennel Club Regulations or under the rules of any governing body recognised by The Kennel Club.

PUPPY STAKES For dogs of six and not exceeding twelve calendar months of age on the first day of the Show (i.e. born between 30th May 2023 and 30th November 2023 inclusive).

S.C.C.A. JUNIOR STAKES For dogs of six and not exceeding eighteen calendar months of age on the first day of the Show (i.e. born between 30th November 2022 and 30th November 2023 inclusive).

S.C.C.A. OPEN CHARITY STAKES For all dogs of the breeds for which the class is provided and eligible for entry at the Show. All the entry fees from this class will go to Southern Counties' designated charity for the year. For 2024 the beneficiary is the NHS.

S.C.C.A. MEMBERS' STAKES Open to dogs owned by fully paid-up members of Southern Counties Canine Association. Membership for 2024 MUST be paid by the close of entries at latest.

S.C.C.A. RESERVE CC WINNERS' STAKES Open to dogs which have won one or more Reserve CCs but have not won a CC before 15th April 2024.

KENNEL CLUB GOOD CITIZEN DOG SCHEME CLASS For dogs that have achieved their GCDS Bronze Award Certificate or above.

KENNEL CLUB BREEDERS' COMPETITION Each team will consist of a minimum of three and maximum of four dogs of one breed, all bred by the same breeder or breeding partnership. The breeder enters the class and then arranges which dogs are exhibited on the day of the show (from those dogs duly entered for exhibition in another class at this show). Please clearly state the name and affix of the registered breeder(s). Entries will not be taken on the day of the show. Teams will be awarded points/prize money in the KC Breeders' Competition as follows: Points 1st; 30; 2nd 15; 3rd 10; 4th 5. Prize Money 1st Non ABS Prize Fund £20; ABS Prize Fund £25. Please note that Assured Breeders will be credited with a higher prize value. These points will be recorded in the Kennel Club Breeders' Competition record book through the year. The minimum qualification for the Crufts final will be 50 points, with a maximum of 40 finalists including the winning teams from the European and World Dog Shows' breeders' competition. Our Dogs will collate the points and publish a leader board through the year. **Please Note: Dogs which take part in the Breeders' Competition, but are not entered in the show, are required to have a completed entry form. Owners of these dogs must attend the Secretary's office to complete the entry form.**

YKC MEMBERS' STAKES This schedule information MUST be read in conjunction with the full set of YKC Stakes rules available on the Young Kennel Club website (yk-stakes-rules-2024-crufts-2025-print.pdf (thekennelclub.org.uk)). By entering this class, you confirm that you have read and understood the accompanying full set of YKC rules. Members must be a YKC member before entering the competition. YKC Stakes Classes have one age category for you to enter: 06-24 Years. First place in each sub-category will guarantee qualification to Crufts 2025. Further qualification methods can be viewed by reading the full rules. You may enter this class even if you have previously qualified in this class. YKC Classes may be the first and only entry at this show.

ANY VARIETY NOT SEPARATELY CLASSIFIED For breeds of dog for which no separate breed classes are scheduled. These classes are not open to breeds which are listed on the Imported Breed Register.

RARE BREEDS Confined to those breeds not granted Challenge Certificates in the current year, with the exception of those breeds whose registration is confined to the Imported Breed Register.

IMPORTED BREED REGISTER For breeds confined to the Imported Breeds Register and only when an Interim Breed Standard has been published by The Kennel Club. Such breeds may be exhibited in this class with the Best Imported Register / Best Imported Register Puppy being eligible for Best in Group / Best Puppy in Group or Best in Show / Best Puppy in Show as relevant. Such breeds may be entered into Imported Breed Register classes and/or Any Variety or Stakes classes, with the exception of AVNSC classes, for which they are not eligible.

ANY VARIETY A Variety Class is one in which more than one breed or variety of a breed with a breed standard can compete.

ADVISORY NOTICE

NOT FOR COMPETITION Societies may at their discretion, accept Not for Competition entries. Societies may accept such entries from breeds of dog not included within the title of the Society and at Shows held over more than one day, such entries may be accepted on any day from any breed.

The slip road for the Showground is **just 300 yards** from the junction.

FROM THE SOUTH you go underneath the motorway at Junction 13 and leave the A34 by the slip road as above.

FROM THE NORTH take the East Ilsey turn off the A34 if signposted — the junction after the one for Chilton. Follow the sign for Compton, then Hampstead Norrey, then Hermitage and Newbury.
